# Plan Summary [2024-25]

### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Sutter Peak Charter Academy (SPCA) opened in the fall of 2015 as an independent charter school. SPCA was founded by the Pacific Charter Institute, a 501 (c) 3 tax exempt non-profit organization of charter school leaders in the Northern California area. Currently, Pacific Charter Institute's Board of Directors governs six public charter schools serving approximately 4000 students. Currently SPCA maintains an enrollment of 642 students.

Sutter Peak Charter Academy offers TK-12 students a personalized learning program. Every SPCA student has access to one-to-one teaching through student-tailored, standards-based curriculum. Sutter Peak was founded on the principle that education works best when it is tailored to student's individual strengths and needs. Our goal is to work cooperatively with students, parents, and the broader community to develop each student's greatest potential. We leverage the flexibility of the independent study model to empower SPCA students to meet their educational goals. Sutter Peak Charter Academy has a clearly stated vision and mission based on its student needs, current educational research, and the belief that all students can achieve the highest academic standards.

Vision - "SPCA is developing self-motivated, educated individuals who will spread the wealth of knowledge worldwide in a meaningful way."

Mission - "Sutter Peak Charter Academy empowers students to take charge of their education by connecting their individual needs and interests to a rigorous learning plan, thus creating responsible citizens, critical problem- solvers, and lifelong learners."

Central to Sutter Peak Charter Academy's vision and mission is the Academic Triangle, defined by the interdependent relationship of the teacher, the student, and the parent. The dynamics surrounding this vital geometry assists in ensuring that the student and parent both

realize the scope of the overarching goals for all students at the school. The teacher develops personal learning tools to successfully complete the curriculum. The Academic Triangle is the symbol for what is expected for each student in that it empowers each agent of the triangle to take charge of the educational plan, regardless of the stability of all of the legs.

Both the mission statement and vision present clear expectations that students become active participants in their own education and their future. The strength of the Academic Triangle lies in its essential ability to support students who may not have sufficient academic stamina or self-motivation at the time of enrollment. The teacher or parent may have to take on the greater role until the student progresses to expected levels. Further, the school's commitment to the educational pursuits of each student is evident in the variety of curriculum provided to match a student's abilities and interests.

## **Reflections: Annual Performance**

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

During the 2023-2024 academic year Sutter Peak Charter Academy continued to make significant progress in academic performance for both English Language Arts (ELA) and mathematics.

1. ELA and Math Academic Achievement:

2023 CAASPP showed gains of 4.6 on the ELA DFS and 9 on the math DFS.

These achievements can be attributed to the effective implementation of progress monitoring and focused intervention.

2. Early Literacy Achievement:

In the spring of 2024, a significant percentage of our K-2 students attained grade-level benchmarks in early literacy.

4. College and Career Readiness:

44.4% of graduating 12th graders were deemed college or career-ready based on the college and career indicators, highlighting our holistic approach to preparing students for post-secondary success.

Identified Areas for Focus Based on Dashboard Insights:

1. Continued Progress Monitoring of Academic Achievement:

Emphasizing the importance of ongoing assessment and evaluation to ensure sustained academic growth across all grade levels, student groups, and subjects.

2. Parent Engagement:

Strengthening partnerships with parents and guardians through enhanced communication and involvement initiatives to support student success both at home and in school.

3. Refinement of Student Preparation for College and Career Readiness:

Further refining strategies and resources to equip students with the essential skills and knowledge needed for successful transitions into higher education or the workforce.

4. Early Literacy:

Building upon the achievements in early literacy by implementing targeted interventions and instructional approaches to support students in mastering foundational literacy skills.

5. English Language Progress- The ELPI decreased by 37.7% and this area will be addressed by the hiring of an EL teacher.

No resource disparities have been identified among subgroups at Valley View Charter Prep. All students receive equal funding, and additional academic support services are provided through supplemental and federal funds.

Measures are in place to ensure equitable access to educational resources, including technology, internet connectivity via hotspots, and essential school supplies, particularly for homeless, foster youth, and financially disadvantaged students. In response to these findings, Valley View Charter Prep committed to implementing targeted interventions, professional development programs, and collaborative initiatives to address the identified needs comprehensively. Through a concerted effort involving stakeholders, educators, and the wider community, we aim to foster an inclusive learning environment that empowers all students to thrive academically and beyond.

Evaluation of the California School Dashboard (Dashboard) data demonstrated a necessity to continue academic growth by continued focus on Progress Monitoring and Interventions as well as continued efforts aimed toward K-2 literacy in reading and math, along with interventions for EL, special education, and SED students.

While 58% of students grades 3–8 and 11 met or exceeded the standard in English Language Arts on the Smarter Balanced assessments this proficiency level drops significantly for SED students to 48%.

Similarly, only 39% of students across grades 3–8 and 11 met or exceeded the standard in Mathematics on the Smarter Balanced Assessments, with percentages for SED students 29% and Hispanic students 27%.

Sutter Peak is committed to elevating ELA and mathematics performance across all grade levels and student demographics through interventions aimed at augmenting student learning. Specifically, the support provided by a dedicated EL teacher will be instrumental in propelling progress towards English Language Proficiency.

The progress towards this goal shall be monitored using the following metrics: CAASPP, MAP, DIBELS, mClass, and ELPI.

Sutter Peak students spring survey results were positive as well, with 77% reporting overall satisfaction, 85% reporting it is easy to use online tools, 100% feel they know how to get help on assignments, and 67% expressing happiness at being enrolled at SP.

Enhancing opportunities for families to participate in in-person school activities will be crucial for fostering increased satisfaction and facilitating additional avenues for supporting the social and emotional well-being of both students and families.

#### • 13. LCFF Carryover — Percentage (12 divided by 9)
